After ~30 days, practitioners move into the Apprenticeship stage where they observe, shadow and rely on coaches/supervisors for instruction.

Once WFT has been completed, core team members are required to attend their respective role-specific training.

- **Family Support Specialists** must attend “**Wraparound Partners in Possibility**” through OFSN
- **Youth Support Specialists** must attend “**Impact Makers**” through Youth Era
- **Care Coordinators** must attend “**CC Foundational Training (CCFT)**” through SOCI

Registration for these trainings may overlap, so please make sure to ensure you are registered for WFT as well as your corresponding role-specific training.
